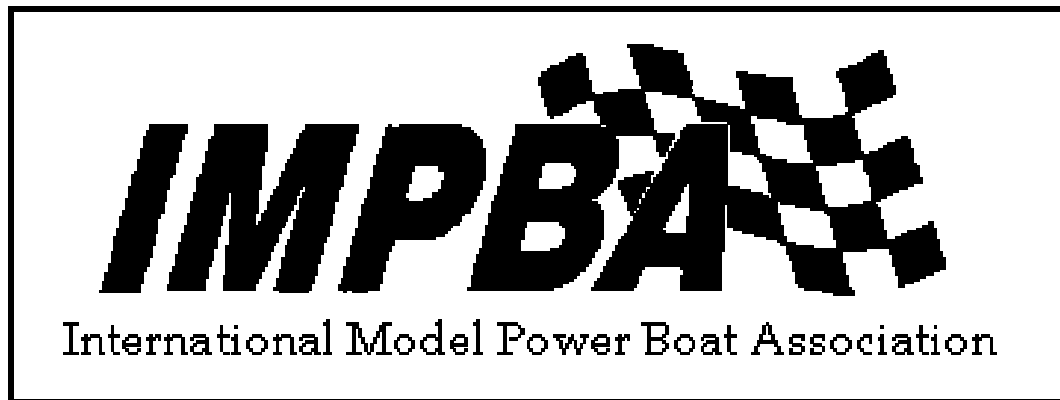

## Map of Districts and Officers

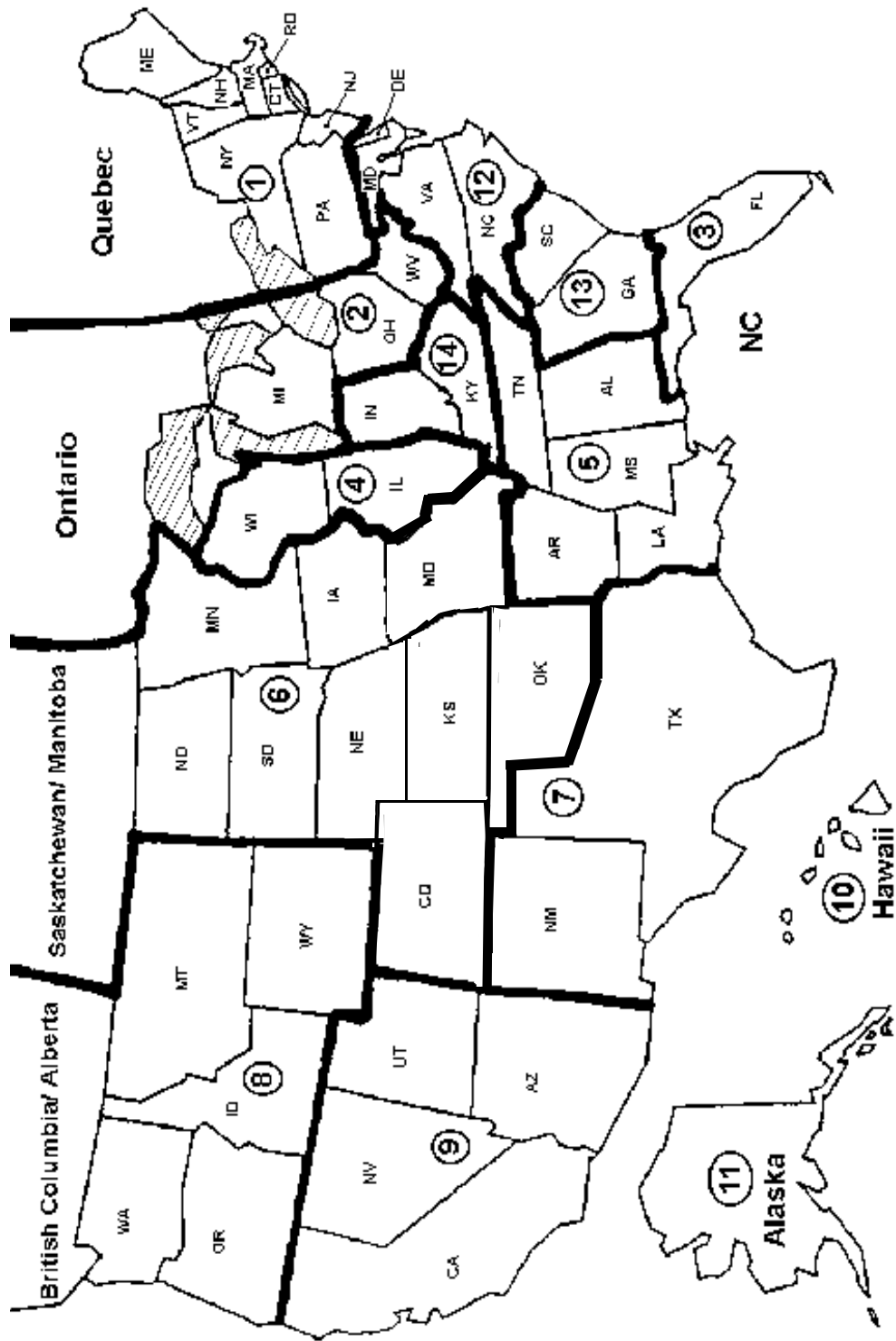
Map of Districts .....	A - 2

### District 1 & 2 Identification Method

The eastern edge of District 2 would be a line between, Aylmer (in the south), St. Mary's (middle), then Goderich (as the northern limit), and all points south and west would be district 2. District 1 would start at Tillsonburg, Ingersoll, Woodstock, Stratford, Listowel and all points East and North over to the Ontario/Manitoba provincial boarder.
